

APPENDIX III.IR.B.I. Classification of Industries

1. Grains and Pulses : Milling, grinding, parching and kinds of processing of grains and pulses.
2. Edible Vegetables and Hydrogenated Oils : Pressing and refining edible vegetable oils, manufacture of hydrogenated oils, making of butter, cheese, ghee and other dairy products.
3. Sugar : Manufacture of gur and manufacture and refining of raw sugar, syrup and granulated or clarified sugar, from sugarcane or sugar beets.
4. Tobacco : Manufacture of Tobacco products such as cigarettes, cigars, bidis, smoking and chewing tobacco and snuff. Stemming, redrying and other operations connected with preparing raw-leaf tobacco for manufacturing are also included.
5. Cotton Textiles : Cotton spinning, weaving, and finishing (including bleaching, dyeing and printing).
6. Silk-Rayon & Woollen Textiles : Silk reeling, spinning, weaving etc. Manufacture of rayon or artificial silk (including staple fibre) and woollen spinning weaving etc.
7. Medicines and Pharmaceutical Preparations : Medical and pharmaceutical preparations.

8. Matches.

9. Pottery, China Earthenware and Structural Clay Products :

Manufacture of structural clay products such as bricks, tiles, crucibles, architectural terra cotta; stove lining, chimney, pipes and tops, refractories etc. Manufacture of clay products such as pottery, China and earthenware (including porcelain and crockery).

10. Paper & Paper Products : Paper and paperboard mills, and the manufacture of articles of pulp, paper and paper board (including straw-board). Manufacture of pulp, from wood, rags and other fibres and conversion of such pulp into any kind of paper, paper board and fibre building board. The conversion of paper and paper board into products such as paper bags, boxes and other containers, cards, envelopes and wall-paper. To include also the manufacture of all kinds of pressed and moulded pulp goods such as pulp plates and utensils.

11. Iron & Steel : Manufacture of iron and steel including all processes from smelting in blast furnaces to semi-finished stage; that is, the production of billets, blooms, slabs or bars; re-rolling into basic forms such as sheets, plates, stripes tubes, rails, rods, tinplate, rough castings etc.

12. Aluminium : Smelting and refining of aluminium metal and its manufacture into basic forms such as ingots, bars, billets, sheets, strips, circles, sections, rods, pipes, tubes, castings and extrusions.
13. Basic Industrial Chemicals : Manufacture of basic industrial chemicals such as acids alkalies, salts, intermediates, explosives and fireworks, synthetic resins and other plastic raw material (including synthetic fibres and synthetic rubber), power alcohol and other basic industrial chemicals not elsewhere classified.
14. Cement : Manufacture of all kinds of hydraulic cement, such as portland, natural, ^{masonry}~~masonry~~, puzzoland, fibre and Roman.
15. Transport Equipment : Manufacture and repair of equipment for the transportation of passengers and freight by ships and boats, bicycles, aircraft, coach building and transport equipment not elsewhere classified e.g. animal or hand-driven vehicles (excluding railway equipment and motor vehicles).
16. Electrical Machinery Apparatus, Appliances etc. Manufacture of machinery, apparatus and supplies for the generation, storage, transmission and transformation of electric energy, such as electrical generating, transmission and distribution apparatus, electrical appliances including household appliances, insulated wire and cable, electrical equipment for motor vehicles, aircraft and railway locomotives and cars, electric lamps, fans, communication equipment and related products including radios etc.

17. Machinery : (Other than Transport etc.) : Manufacture of machinery & prime movers other than electrical equipment. To include also machine shops engaged in producing machine and equipment parts, etc. textile machinery and accessories; agricultural implements; sewing machines producer ~~glass~~ gas plants.etc.
18. Ferrous/Non-Ferrous Metal Products : Manufacture of basic metal forms into finished articles such as tin cans and other tinware; hand tools cutlery; hardware, hollow ware, metal stampings; lighting fixtures, fabricated wire products; metal bolts, nuts, washers, and rivets, collapsible tubes, ^{ordnance} ~~ammunition~~, including small arms and accessories, all other metal products not elsewhere classified. This group includes such industries as those engaged in enamelling, lacquering and galvanizing, plating and polishing metal products; black smithing and welding.
19. Jute Textiles : Jute spinning, weaving, etc.
20. Other Chemical Products : Manufacture of chemical products such as perfumes, cosmetics and other toilet preparations, soaps and other washing and cleaning compounds, paints, varnishes and lacquers' polishes; inks; candles, starch and starch products, lac including shellac. Glues and gelatine insecticides, fungicides, weedkillers included.

21. Rubber and Rubber Products : Manufacture from natural or synthetic rubber, gutta percha, balate, or gutta siak, of all kinds of rubber products such as tyres, rubber footwear, mechanical rubber goods and rubber sundries, reclaiming of rubber from used types, scrap and miscellaneous waste rubber; manufacture of rebuilt and retreated rubber tyres.
