From the State Survey Officer, Office of the Director of Public Instruction, D.O.No.SSO/PC/71, dt. 12.7.1971.

ORDER:

Since some time past Government have been considering 1. the starting of Residential Schools in the rural areas of the State. The intention in starting such schools is that they should serve as centres of excellence. It has been found by experience in several states like Bihar, Maharastra etc. that institutions run generally on the lines of Public School system which are residential in character and fully equipped with all facilities and staffed with competent hands, serve as feeder institutions capable of producing students of outstanding The impressive number of successful candidates from calibre. those States in All INdia competitive Examinations for admission to professional colleges of All India character has been rightly attributed to the existence of institutmons of this nature. This apart, they set the standard for academic excellence and by so doing bring about the desired improvement. Judged, therefore, from all aspects, the development of a few such institutions in this State, particularly catering to rural requirements, so far neglected, is of urgent necessity and cannot be postponed further.

2. The entire issue has been thoroughly discussed at all levels. An Officer of the Education Department visited the Netherhat School, an exempler in this line, and made a detailed study of its pattern and how it is run. Further the Government of India have evolved a scheme of awarding scholarships to two students from each Samithi Block. The scheme is to be put in operation from this year. It has been proposed to make use of this scheme in starting the Residential School. That is to say, the 8th class of this school to be started this year will consist of only those merit scholarship holders. So far as 5th class is concerned, admission will be by a special selection process based generally on competitive examination of the pattern adopted by the Netherhat School.

Government have therefore, decided that one school 3. may be started in this State at Sarvail in Nalgonda District with effect from the current academic year and issue the following orders:

The School shall be managed by a Managing Committee consisting of

- a) the Secretary to Government, Education Department,
- b) Sri M.V. Rajagopal, M.A. (Cantab), IAS., Secretary to Government in Health and Municipal Administration Department,
- c) Secretary to Government in Finance Department or his nominee.
- d) The Director of Public Instruction or his nominee,
- e) Principal, Member Secretary.

The Committee shall be headed by the Secretary to Government in Education Department.

Government sanction the staff as indicated in 4. Annexure to this order to the School.

Sanction is accorded to the incurring of an expenditure not exceeding Rs.4.50 lakhs (Rupees four lakhs and fifty thousands only) towards, the following during 1971-72.

6. The expenditure shall be debited by opening a new sub-head "Government. Residential Schools" under "28-Education - D Special m- Government Special Schools schemes included in the Fourth Five Year Plan" with usual sub-heads of appropriation - pay of officers, Pay of Establishment, Allowances, office contingencies and other charges.

7. The expenditure on the Upper Primary sections of the school will be included in the schemes pertaining to Primary Education which is reimbursable by Government of India.

8. This order issues with the concurrence of Finance Secretary, dt. 23.9.1971.
